### **Changes to Bus Passes and Parking**

From today (15 June) the following changes to traffic and travel arrangements will be made as restrictions are relaxed and more people start to move around:

- Concessionary bus passes will revert to their normal hours of operation (9am midnight Mon-Fri and any time Sat-Sun). OCC is working with the bus companies to manage these changes.
- Parking charges will be reintroduced at the Oxford park and ride sites.
- Parking concessions for key workers both in on-street pay and display and offstreet council car parks will be maintained.

# **Councillors Covid-19 Priority Fund**

So far, 40 grants, totalling nearly £30,000 have been awarded by Cherwell councillors, to groups responding to the coronavirus crisis. Recipients have ranged from large charities to parish councils and small neighbourhood based support groups. Funded projects have included emergency food supplies; teleconferencing facilities; childcare for key workers; isolation packs; PPE for volunteers; volunteer logistics; a women's refuge shelter; counselling support for victims of abuse.

We remain ready to process applications as soon as they come in. The application form and guidance on how to apply for the <u>Councillor COVID-19 Priority Fund</u> is on <u>cherwell.gov.uk</u>. All applications should be sent electronically to <u>grants@cherwell-dc.gov.uk</u>

### **Shielded Residents**

Currently there are 2,778 residents who have been required to shield in the district and restrictions are predominantly still in place for this group. Cherwell District Council provides a contact and troubleshooting service for all shielded residents, and continues to work with voluntary sector partners to provide practical and emotional support. An enormous amount of support continues to be provided to shielded and vulnerable residents across the district by parish and neighbourhood based community support groups.

### **Track and Trace Scam**

Oxfordshire All In reports a new scam that tries to convince people that they have been in contact with someone who has been tested positive, pretending to be NHS Track and Trace. They then either ask for money to send them a test, or try to get hold of their personal details.

#### Real contact tracers will:

- Call you from 0300 013 5000
- Send you text messages from 'NHS'
- Ask you to sign into the NHS test and trace contact-tracing website

#### Real contact tracers will never:

- Ask you to dial a premium rate number (for example, those starting 09 or 087)
- Ask you to make any form of payment or purchase a product or any kind
- Ask for any details about your bank account
- Ask for your social media identities or login details, or those of your contacts
